# HOUSE SUBCOMMITTEE PORES OVER PANDEMIC IMPACTS ON MARINER FORCE

The impact of the pandemic on the nation's maritime sector took center stage at a House Subcommittee hearing this week as several expert witnesses helped Members of Congress understand the unique challenges the industry faces. Seaports, shipbuilders and a pair of coalitions representing U.S. shipping interests, including the M.E.B.A., testified at the hearing before the Subcommittee on Coast Guard and Maritime Transportation – which is part of the House Committee on Transportation and Infrastructure.

Jim Patti, who heads up MM&P's Maritime Institute for Research & Industrial Development (MIRAID) but was testifying on behalf of USA Maritime, a U.S.-flag shipping coalition that includes the M.E.B.A., discussed the devastating effects a positive COVID case can have on the delivery of goods, as well as mariners who live in close quarters aboard ship. "If a crewmember tests positive for COVID-19 the vessel, depending on the jurisdiction, may be taken out of service and it, along with the entire crew, may be placed into quarantine for an undetermined period of time. The quarantine

and cleaning of the vessel is not only time consuming and extremely expensive for the shipping company, but the delay means that the vessel's cargo will not arrive at its destination when expected and when needed." He stressed that positive cases aboard a ship carrying military cargo could help jeopardize the mission and put the lives of overseas American troops at risk. He told the Subcommittee that mariners must be prioritized for vaccinations to help ensure the flow of commercial and military cargoes. Patti also highlighted the global crew change crisis and pointed out that a medical crisis at sea is now exacerbated by limited disembarkation opportunities because of rigid COVID restrictions at world ports.

The USA Maritime spokesperson also took the opportunity to tick off a list of vital concerns shared by U.S.-flag shipping interests. The Subcommittee was again reminded that U.S. sealift capability is in dangerous straits because of the shortfall in the mariner pool, the limited number of U.S.-flag vessels and the need for more cargo – components that are intrinsically linked. "We can address this shortfall in the American maritime manpower pool," he said, "by ensuring that greater amounts of government-generated and commercial cargoes move on U.S.-flag ships, thereby increasing the size of the U.S.-flag fleet and the number of American merchant mariners to crew the vessels needed to meet Department of Defense requirements."

He told the Committee that U.S.-flag shipping is encouraged by President Biden's "Buy American" Executive Order and the Chief Executive's directive to federal agencies to strictly enforce the Jones Act. He also discussed the importance of the Maritime Security Program and the need to fund the fledgling Tanker Security Fleet.

Mario Cordero, Port of Long Beach Executive Director who testified on behalf of the American Association of Port Authorities (AAPA), said that this past year has been "one of the most erratic and volatile years in terms of container volumes" but frontline workers have helped seaports weather the significant impacts of COVID-19. He told the Subcommittee that if we fail to take action on priority testing and vaccination of port workers, "we risk jeopardizing the fluidity of the movement of cargo." He called for additional funding for the Maritime Transportation System Emergency Relief Program to help ports mitigate pandemic impacts.

Crowley's Michael Roberts, who testified on behalf of the American Maritime Partnership, told the Subcommittee that they can rest assured "that the American domestic maritime industry will continue to deliver the goods that are essential to our nation despite one of the most difficult work environments in a generation." He trumpeted the Jones Act and noted that the statute now applies to offshore wind development on the Outer Continental Shelf. He also repeated warnings about China's exponential growth of its commercial maritime industry that is putting U.S. national security interests at risk.

#### ADVISORY ISSUED FOR MARINERS NEAR LIBYA COAST

Mariners face enough challenges in the current environment, but those transiting near the coast of Libya need to keep an eye out for an additional threat. The Maritime Administration has issued an Advisory warning that U.S.-flag ships – and for that matter, any commercial vessel – transiting in waters close to that part of Africa could be potential targets for mayhem. The MarAd Advisory states that the ongoing conflict in Libya could pose a danger to commercial vessels in the form of (but not limited to) "missiles, rockets, artillery, mines, small arms, aircraft, and unmanned aerial vehicles."

### INTENTION TO HOLD FRC MEETING IN-PERSON

M.E.B.A. intends to host a Financial Review Committee meeting in-person at Headquarters in late April. Last year's meeting was postponed until September because of the pandemic. This year's FRC is scheduled to take place from Tuesday, April 27 through Thursday, April 29. The Committee will be comprised of six rank-and-file members who will be elected at the April membership meetings. The six-person FRC is a democratic safeguard adopted by the M.E.B.A. in the mid-1990s to examine Union finances from the previous year. Members will be elected during the April membership meetings hosted in NY/NJ, Houston, Oakland, Norfolk, Tampa and Seattle.
