### FARM BILL CONFEREES BEGIN WORK - FOOD FOR PEACE AT ISSUE

57 Senate and House Conferees began meeting this week to work out final details of the 2018 Farm Bill – a five-year package that includes the authorization for food aid programs.

The House and Senate each passed their respective Farm Bill versions in July, with the final details to be worked out through the Conference process prior to expiration of the current authorization on Sept. 30th. The Senate version includes several provisions which would negatively impact the U.S. Merchant Marine by decreasing the total amount of food aid available for export. Maritime unions and carriers are actively lobbying both the House and Senate to ensure that the House version prevails.

### GEN LYONS INSTALLED AS TRANSCOM COMMANDER

At a change of command ceremony last week at Scott Air Force Base, Army General Stephen R. Lyons took over as the new Commander of the U.S. Transportation Command succeeding the retiring Gen. Darren McDew. Gen. Lyons is the first ever non-Air Force officer to head up TRANSCOM.

He previously served as Deputy Commander at TRANSCOM under both Gen. Paul Selva and briefly under Gen. McDew before his assignment to the Joint Chiefs of Staff as Director for Logistics. TRANSCOM is responsible for the global, joint movement of combat units, sustainment cargo, and service member household goods and privately owned vehicles.

Like previous Commanders, General Lyons understands that the military is dependent on the U.S. Merchant Marine to help project U.S. power overseas.

# APL TALKS CONTINUE LATER THIS MONTH, ADDITIONAL RANK & FILE PARTICIPATION SOUGHT

M.E.B.A. is set to continue negotiations with American President Lines later this month in Oakland. The Union is interested in supplementing our negotiating team with qualified rank and file members.

The first round of talks with APL began in late August as the parties work on a new contract covering Deep-Sea engineers as well as Port Engineers. The current agreement expires on September 30.

Executive Vice President Adam Vokac is leading negotiations joined by L.A. Branch Agent Rich Doherty and Oakland Patrolman Maxim Alper. Chief Engineer Fred Cuzner, 1st A/E Trevor Lapham, Rotary Engineer Kurt Landwehr and M.E.B.A. retiree Duncan Ballenger participated in the late August talks.

### AFL-CIO LAUNCHES TV AD HIGHLIGHTING WORKER POWER

The survey is part of a campaign that is also promoting awareness of the Nautilus Federation's Joint Assistance & Support Network (JASON) which aims to safeguard members' rights to fair treatment after accidents.

## THANKS TO THOSE WHO COMMENTED ON MARITIME DEREGULATION DOCKET

Many thanks to members who added their input to an Office of Management and Budget comment period on maritime industry deregulation. The comment period is now closed, but thanks to many of

our members, applicants and retirees, there is a more balanced and level-headed sampling of responses the agency will be reviewing.

The docket was set up to accept input on related agency requirements that should "be modified or repealed to increase efficiency, reduce or eliminate unnecessary or unjustified regulatory burdens, or simplify regulatory compliance while continuing to meet statutory missions."

Some initial commenters called for an end to the Jones Act while others used the opportunity to savage cargo preference requirements. But eventually, comments from mariners, relevant industry organizations and others provided full-throated defenses of those crucial statutes and stressed that any government deregulation of the industry should avoid toppling such programs and laws that keep the U.S. Merchant Marine afloat.

If lawmakers and those in government don't understand - or aren't made aware - of the importance of programs and statutes upholding the U.S. Merchant Marine, we could find our livelihoods legislated away with the stroke of a pen. Members, applicants and retirees who stay vigilant and assist the fight for U.S.-flag shipping continue to prove extremely valuable to the cause.

### FEASIBILITY OF MODIFYING WSF VESSELS TO HYBRID-ELECTRIC SUPPORTED

A newly-released study justifies the modification of three Washington State Ferry Jumbo Mark II-class vessels to hybrid-electric power. Elliott Bay Design Group (EBDG) prepared an analysis into the feasibility of modifying the TACOMA, WENATCHEE and PUYALLUP to integrate battery power into their propulsion plants. The study discussed the initial power and energy requirements for each route (Seattle to Bainbridge and Edmonds to Kingston), the sizing of the battery banks, new arrangements on the vessels, impacts to the existing system and life cycle cost analysis.

Results from the Jumbo Mark II study not only proved the feasibility and financial justification of the vessel conversion but highlighted several long-term benefits for Washington State Ferries and the impacted region. Benefits included zero-emission crossings on the proposed routes, major reductions in NOx and particulate emissions after the conversion and near elimination of diesel fuel consumption for the Jumbo Mark II vessels. The three ferries are the largest in the Washington State fleet and the biggest emitters of greenhouse gas emissions. Collectively, these three vessels burn approximately 4.2 million gallons of fuel per year – more than 26% of the fleet's consumption.

This project is said to have an enormous impact in meeting WSDOT's 2020 emissions targets set by the Washington State Legislature and complying with the Governor's Executive Order to transition to a zero-carbon emission fleet.

### GREAT LAKES LIMESTONE TRADE STAYS STEADY

Shipments of limestone on the Great Lakes totaled 3,941,085 tons in August, a near carbon copy of both a year ago and July of this year. Limestone cargos also bettered the month's 5-year average by 5.8 percent. Loadings from U.S. quarries totaled 3.248 million tons, a decrease 3.3 percent, or 110,000 tons, compared to a year ago. Shipments from Canadian quarries totaled 693,003 tons, an increase of 9.4 percent or roughly three loads in a mid-sized laker.

Year-to-date the Lakes limestone trade stands at 17.2 million tons, an increase of 3.5 percent compared to a year ago. Loadings from Michigan and Ohio quarries total 14.1 million tons, an increase of 3.3 percent. Shipments from Ontario quarries total 3.1 million tons, an increase 4.5 percent.
