### FRC COMPLETES REVIEW, FORWARDS REPORT

A six-person rank-and-file Financial Review Committee spent three days at M.E.B.A. Headquarters this week scrutinizing the Union's financial records for calendar year 2022. The FRC was created as

a Democratic safeguard adopted by the M.E.B.A. in the mid-1990s to examine the Union's finances from the previous year.

This year, the Committee was made up of the following six members: Rayomond Collector (Houston) who served as Chairman, Chris DeFonce (NY/NJ), Michael Ferrino (Tampa), Timothy Cogan (Oakland) and Steven Walker (Seattle). The Committee member elected in Norfolk could not attend because of a shipping assignment. Member Kenny Smith, who was elected as the NY Alternate, filled in for the Norfolk member and served as the Alternate for the Committee.

The FRC members signed off on a report that will be made available at the halls and voted upon by members at the regular May membership meetings. Many thanks for their hard work this week and for participating in this important democratic process.

# UNIONS LOOKING FOR U.S. PRESENCE IN EMERGING OFFSHORE WIND INDUSTRY

M.E.B.A. as well as other unions and U.S.-flag shipping interests are keeping Congress focused on the need to stress an American presence in the emerging offshore wind industry.

The House Transportation & Infrastructure Committee has been deliberating over the Coast Guard Reauthorization bill this week and the M.E.B.A. and others are reminding Members to ensure that American workers don't lose out to our foreign counterparts as the framework of the burgeoning wind industry is developed.

Committee members approved the Coast Guard bill this week along with an M.E.B.A.-backed provision requiring mariners serving on foreign-flagged vessels on the Outer Continental Shelf to be either U.S. citizens or citizens of the nation where the vessel is flagged. Current law requires that all vessels, rigs, platforms, or other offshore structures be manned by U.S. citizens or lawful permanent residents, but foreign companies are exploiting the laws, as written, to use low-wage foreign mariners for this work and allowing them to skirt U.S. taxes and labor laws.

A joint letter recently sent to the Committee by the M.E.B.A., MM&P and Transportation Trades Department (AFL-CIO) notes that if Congress fails to act on this issue, "we run the risk of leaving our nation's renewable energy infrastructure vulnerable to foreign adversaries operating in U.S. waters."

Last year, the provision passed in the House but the Congressional allies of the oil and gas industry helped doom the measure in the Senate.

Opponents say that Americans don't have the workforce or fleet requirements needed for this up and coming industry and therefore would cripple its development. The M.E.B.A./MM&P, TTD letter notes, "While we recognize the capacity of U.S. mariners and vessels does not currently exist to meet the long-term demands of the offshore wind industry, we remain concerned these gaps are currently being exploited to hire foreign labor under existing "flags of convenience" vessel operators for extremely low wages and poor working conditions." They asked Congress to pass the provision which will help reduce this insipid industry trend. That would allow American workers to get in on the ground floor of offshore wind efforts so that the U.S. can begin ramping up its workforce to be players in this lucrative new industry.

# M.E.B.A.'S VOKAC, INTERLAKE'S BARKER HONORED WITH "FRIEND OF SEAFARERS" AWARDS

M.E.B.A. President Adam Vokac was honored with the Seafarers International House (SIH) "Outstanding Friend of Seafarers" award last week in New York City which he accepted on behalf of the M.E.B.A. and our hardworking members. Interlake Steamship Company President Mark Barker was also a worthy recipient of the honor as was Global Container Terminals USA President John Atkins. The award is bestowed upon individuals who have made advances on behalf of the maritime community and who are dedicated to the welfare of seafarers. The SIH, celebrating their 150<sup>th</sup> year, is a charitable organization that provides seafarers and travelers with pastoral care, hospitality, social assistance and advocacy.

In his remarks, President Vokac discussed some of the issues the industry faces after COVID restrictions dampened the quality of life for seafarers leading to an exodus of mariners and sparking new recruitment and retention challenges. "For all the committees out there currently looking at ways to solve the mariner shortage," he said, "it's not complicated – make the jobs desirable again, and people will come."

He discussed the Union's perennial push to improve the lives of our members, by increasing their pay, safety and benefits. He mentioned his appreciation of his fellow honoree Mark Barker, who heads up a company that "gets it." President Vokac said that Interlake's Barker "understands and embraces the fact his company is literally driven by the mariners themselves. Mark, I applaud your commitment to seafarers and look forward to our continued partnership."

# CONGRESSMAN STRESSES CARGO PREFERENCE IMPORTANCE AT USAID HEARING

An interesting exchange at a House Subcommittee hearing this week highlighted concerns that some Congressional Members have with the Government's sometimes less-than-strict adherence to cargo preference statutes. Existing requirements stipulate that U.S.-flag vessels must be utilized for at least 50% of Government-impelled cargoes and 100% of military shipments.

Congressman Jerry Carl (R-AL) delighted U.S.-flag interests during a U.S. Agency for International Development (USAID) budget request hearing when he questioned AID Administrator Samantha Power on U.S.-flag Food Aid carriage.

Rep. Carl, serving in his second term, opened his questioning of the Administrator with the admission that that his father's lifetime service as a mariner, including through World War II, has made the U.S. Merchant Marine dear to his heart. He called the U.S.-flag fleet "critical to our nation's national security" and questioned Powers about her agency's adherence to cargo preference requirements. The U.S.-flag shipping community has raised concerns that USAID has unnecessarily bypassed such requirements in the past. Rep. Carl prefaced his questions by stating that he believes "it's important we make sure that the U.S. fleet remains healthy, so they are ready when we call on in an emergency or in war times...USAID's cargo is not only critical to the community around the world, but also keeps the U.S.-flag fleet ready."

Power launched into a non-committal answer that also stressed her agency's willingness to provide food aid through direct cash assistance - which has the effect of diminishing the amount of food aid

cargo carried by the U.S. Merchant Marine and decreases the overall amount of funding available to purchase commodities from U.S. farmers.

Rep. Carl seemed to acknowledge that he didn't receive a clear enough answer from the Administrator but closed his questioning down by announcing, "I'd also like to take just a moment to thank all of our Merchant Marines for all they do and the hard work of getting goods from "here" to wherever "there" is, in a timely manner."

# BUD SHUSTER, FORMER T&I CHAIR DRIVES OFF INTO THE SUNSET

Former Congressman Bud Shuster, who was an effective Chairman of the Transportation & Infrastructure Committee from 1995-2001, died last week at the age of 91. Although most renowned for his dedication to modernizing the nation's highways and aviation systems, Shuster, supported by M.E.B.A.'s Political Action Fund, was an effective advocate for the U.S. maritime industry and succeeded in championing multiple initiatives and key funding benefiting U.S. shipping. He served in Congress for 28 years.

The T&I Committee paid tribute to Shuster this week saying, "Chairman Shuster was a force, and our Nation's highways, aviation system, ports and waterways, rail network, water systems, and more all benefited from his ability to bring together Members of Congress from across the political spectrum in support of infrastructure."

#### MMC DELAYS – MARINERS CAN CHECK STATUS ONLINE

An increase in application volume and ongoing technical difficulties with the credential production equipment at the National Maritime Center (NMC) have caused concerning delays with the issuance of Merchant Mariner Credentials (MMC). These technical issues do not affect the processing of mariner medical certificates or endorsements, only applications for MMCs.

As detailed in Marine Safety Information Bulletin 06-23 issued this week, a verification process is available to assist mariners in the interim. For mariners who will be serving on domestic voyages only, the mariner, marine employer, and Coast Guard may use the MMC application verification process to determine whether they have met the requirements to be issued an MMC with a specific endorsement. The authority of their MMC may be verified using a credential verification process. For MMC verification for any international voyages, contact NMC directly for priority printing of your MMC. Mariners may contact their Customer Service Center via Live Chat or by calling 1-888-IASKNMC (427-5662) for assistance. #### CANTWELL ON TAP FOR SALUTE TO CONGRESS AWARD
