LABOR LEADER, SIU PRESIDENT EMERITUS MIKE SACCO: 1937-2023

The Seafarers International Union announced that SIU President Emeritus Mike Sacco crossed the bar in St. Louis on Thursday, December 28 at the age of 86. It was reported that he passed of natural causes surrounded by family, ten months after his retirement from the union. Sacco had served as SIU's President for nearly 35 years and had been a tireless and vocal advocate for the US maritime industry.

Mike Sacco's association with the SIU dated back to 1958 when he shipped out on various vessels before transitioning ashore in the 1960s where he assumed a number of union roles, including patrolman, port agent, and headquarters representative. He was the longest serving SIU President, having taken over in 1988 following the death of President Frank Drozak.

A Brooklyn, New York native, Sacco's commitment to service also included a stint in the U.S. Air Force from 1954 to 1958.

M.E.B.A. President Adam Vokac was saddened by the news but expressed his appreciation and admiration for Sacco's strong leadership during his long career battling on behalf of U.S. mariners and the labor movement. Extending the M.E.B.A.'s condolences to the SIU, Vokac noted, "Mike was a towering figure who had a profound impact on an industry that relies on the resilience and strength of its workforce. Beyond the boardrooms and negotiating tables, he recognized the interconnectedness of the maritime community and always guided his union steadily through turbulent seas and calm waters alike. His legacy looms large."

The family is requesting that in lieu of flowers, donations can be made to the <u>Tony Sacco Memorial</u> <u>Scholarship Fund-Charleston Port & Seafarers Society</u> or to <u>St. Jude Children's Hospital</u>. There is a visitation tomorrow - Friday, January 5 at the Kutis Funeral Home at 5255 Lemay Ferry St. Louis, Missouri from 3 pm – 8 pm. A funeral mass will be held the next day - Saturday January 6 at St. Francis of Assisi Catholic Church at 4556 Telegraph Rd. in St. Louis at 11:00 am.

ITF President Paddy Crumlin noted, "What a character Mike was. You could take the man out of Brooklyn, but you couldn't take Brooklyn out of the man. Charismatic, tough, determined, a great and inspirational leader with a sense of humour that always seemed to sum up the situation perfectly. He will be greatly missed."

APL ANNOUNCES CONTINUED REJUVENATION OF ITS U.S.-FLAG FLEET

American President Lines announced that it is continuing to bring in younger vessels to replace ships in its fleet that will also meet new requirements for CO² emissions. APL has nine vessels in its fleet that are enrolled in the Maritime Security Program (MSP). MSP age limits require that older vessels be replaced in the current program before reaching 25 years of age.

Last year, the company replaced the APL GULF EXPRESS with the 14-years younger APL EAGLE that was plucked from the CMA CGM international fleet. The year before, the CMA-CGM DAKAR took the place of the aging APL SAIPAN. In 2021, the CMA CGM HERODOTE (since renamed APL ISLANDER) took over for the old APL GUAM.

Now, the company has announced a tentative schedule to freshen up the rest of the fleet which may include newly constructed vessels. They are planning to bring in two new ships to be named PRESIDENT ADAMS and PRESIDENT GRANT in February and April, respectively. Those vessels will replace the PRESIDENT TRUMAN and PRESIDENT WILSON which are scheduled to flag-out sometime in May. Next, the company plans to welcome the PRESIDENT REAGAN sometime in June and drop the PRESIDENT FRANKLIN D. ROOSEVELT into the CMA CGM international fleet in July.

Under the tentative schedule, the PRESIDENT GEORGE BUSH will be welcomed into the U.S. fleet in late July and the PRESIDENT EISENHOWER will be ushered out in mid-September. The PRESIDENT MONROE would flag-in sometime in October and the PRESIDENT KENNEDY would be removed from the fleet in November. Finally, the tentative schedule targets the arrival of the PRESIDENT JOHNSON in November with no word on the fate of the PRESIDENT CLEVELAND, the other vessel in the U.S.-flag APL fleet not mentioned in this article.

In all cases, the new ships are expected to assume the Maritime Security Program chits from the outgoing vessels. M.E.B.A., MM&P, SIU, SUP and MFOW mariners will continue to crew the replacement ships under the existing agreement with APL.

THREATS IN RED SEA & GULF OF ADEN TAKING A TOLL ON MARINERS

Commercial seafarers are facing additional stress and mental health struggles as drone attacks and pirate threats continue to escalate in the Red Sea and Gulf of Aden. Mariners are on the front lines of two of the world's danger spots as they pass through the Red Sea and Gulf of Aden, with potential attacks coming by both air and sea.

Ship owners and managers should not underestimate the impact this situation can have on the mental health of seafarers according to Charles Watkins, Founder of Mental Health Support Solutions (MHSS). "The feeling of not knowing what could happen and the uncertainty of travelling into the unknown may lead to anxiety and exhaustion, even amongst the most seasoned mariners. "And the more seafarers hear about other ships being attacked, the more reluctant they will be to join a vessel that will be taking that route," he warned.

Furthermore, if they are caught up in an attack, while seafarers may exhibit symptoms of trauma immediately, there is also the possibility that, having initially appeared to have dealt with their distress, there may be a delayed response that could show up months later.

"The emotions felt at the time of the ordeal such as the fear of death, extreme anxiety, helplessness, sadness, anger, a strong longing to escape the situation, and a sense of being out of control, can all lead to short- and long-term effects," he said.

APPLY FOR UNION PLUS SCHOLARSHIPS

M.E.B.A. families have until January 31, 2024 to apply for college education assistance money through Union Plus. Union Plus is awarding \$200,000 in scholarships. M.E.B.A. members, retirees and their families - as well as members of affiliated M.E.B.A. unions - are eligible courtesy of the Union's enrollment in dozens of moneysaving U.P. programs ranging from life insurance to financing children's educations.

Visit <u>www.unionplus.org/scholarship</u> for details. Families of M.E.B.A. members or affiliated members are among past scholarship money recipients. Union Plus Scholarship are granted to students attending a two-year college, four-year college, graduate school or a recognized technical or trade school. Recipients are selected based on academic ability, social awareness, financial need and appreciation of labor.

Applications can be submitted up until Wednesday, January 31, 2024, at noon (EST). Applications arriving after the deadline will not be considered. The award date is May 31, 2024. During the first week of June 2024, award recipients will be notified. A GPA of 3.0 or higher is recommended. The required essays can account for up to half your total score. Scholarship applicants are judged by a committee of impartial post-secondary educators.

Amounts range from \$500 to \$4,000. These one-time cash awards are for study beginning in the Fall of 2024. Students may re-apply each year. Get the official application and all the details including eligibility criteria by visiting unionplus.org/scholarship Now in its 32nd year, the program has given over \$5.4 million in educational funding to more than 3,800 union members, spouses, and dependent children.
