WORK BEGINS TO SECURE FUNDING FOR CRUCIAL MARITIME PROGRAMS

Following the release of President Trump's proposed budget last week, the work begins in earnest to secure funding for crucial maritime programs that help fuel the nation's defense and economy. The budget recommended a \$210 million Fiscal Year 2018 funding level for the Maritime Security Program – \$90 million less than the level appropriated in the current Fiscal Year. In addition, it zeroes out the Title II PL-480 Food for Peace program which provides another source of cargoes for U.S.-flag ships. It also recommends \$10 million in administrative cuts for the Export Import Bank and would cancel \$165 million of the Bank's Tied Aid Fund which provides financing of public-sector capital projects in developing countries. This is worrisome because a portion of cargo generated by the Bank is required to be transported aboard U.S.-flag ships.

However, a President's budget request is only the first step in a months-long process of passing a budget for the Federal Government. Congress does not have to follow the President's budget request, though the White House recommendation traditionally has significant influence on the process – though some in Congress have called the Trump budget "dead on arrival." Congress now takes the lead as they begin to develop annual appropriations bills.

A White House budget is a good indicator of a President's priorities and defense spending is high on the list. That makes it all the more curious that important maritime programs – that help supplement a U.S.-flag fleet crucial to any overseas deployment – were not more strongly embraced in the budget proposal.

M.E.B.A. legislative staff, working with key industry people and Members of Congress, are working hard to secure full funding for MSP and other programs that promote a strong U.S.-flag fleet and keep our fighting forces at full power. You can aid the ongoing battle by supporting the M.E.B.A.'s Political Action Fund. The PAF is a key tool to educate lawmakers about the importance of U.S. shipping. It fortifies the M.E.B.A.'s political relationships in Congress, the White House and in State Capitols. The Fund helps our Union succeed in Washington and is crucial in helping to uphold the maritime policies and programs that are frequently under attack by uneducated lawmakers and interest groups. MAERSK SHIP SWAP-OUT

The MAERSK SENTOSA has been flagged into the U.S. fleet replacing the MAERSK WISCONSIN, part of a two ship swap-out. The SENTOSA sailed out of a Chinese shipyard under the Stars and Stripes in mid-May. Next up, the MAERSK CALIFORNIA will be deployed into the company's international fleet and the MAERSK SELETAR is set to enter the U.S. fleet in a changeover scheduled to take place in the Bahamas next week.

These moves will lower the Maritime Security Program vessel age on two of Maersk's MSP chits. It will not affect M.E.B.A. jobs or wages.

The newer vessels were both built in 2007 and are 318mx40m, 87,500 dwt, 7500 TEU powered by an 11RT-Flex96CB two stroke slow-speed diesel engine rated over 84,000 horsepower enabling a top speed of 25 knots.

"ABOVE-NORMAL" HURRICANE SEASON BEGINS TODAY

Forecasters at NOAA's Climate Prediction Center predict another "above-normal" Atlantic hurricane season this year. The Atlantic hurricane season runs from June 1 through November 30. They predict a 45 percent chance of an above-normal season, a 35 percent chance of a near-normal season, and only a 20 percent chance of a below-normal season. Forecasters predict a 70 percent likelihood of 11 to 17 named storms (winds of 39 mph or higher), of which 5 to 9 could become hurricanes (winds of 74 mph or higher), including 2 to 4 major hurricanes (Category 3, 4 or 5; winds of 111 mph or higher). An average season produces 12 named storms of which six become hurricanes, including three major hurricanes.

NOAA also issued seasonal hurricane outlooks for the eastern Pacific and central Pacific hurricane basins. An 80 percent chance of a near- or above-normal season is predicted for each region. The eastern Pacific outlook also calls for a 70 percent probability of 14 to 20 named storms, of which 6 to 11 are expected to become hurricanes, including 3 to 7 major hurricanes. The central Pacific outlook calls for a 70 percent probability of 5 to 8 tropical cyclones, which includes tropical depressions, tropical storms and hurricanes. The 2016 season was the most active since 2012, with 15 named storms, including 7 hurricanes and 4 major hurricanes. NOAA will update their outlook in early August, just prior to the peak of the season.

REMINDER: INCLUDE ALL DOCS WHEN FILING FOR VACATION PAY

Members are reminded to be thorough when submitting an application for Vacation Pay at the halls and/or with the Plans Office and include all required documents, including Coast Guard Discharges and pay vouchers. Pay vouchers are used to track Social Security Tax maximums, to track wages as Medicare Tax increases and to check for any overlap days that can be identified. As detailed on the application itself, the following documents must be submitted along with your application:

- A copy of the stub portion of your last vacation benefit check.
- Coast Guard discharges and pay vouchers covering all employment since your last vacation.

- Pay vouchers must cover the entire period of employment and show all wages and tax deductions.
- Pay vouchers covering any periods of unearned wages since your last vacation.

Failure to submit proof of all accumulated work performed to the date of application could result in the permanent loss of vacation benefits earned on the employment not submitted.

You may also need to submit:

- A Carry-Over Vacation Form from your last vacation – if applicable.
- An original copy of the Converted Overtime Worksheet, if applicable, regardless of whether or not you are applying for converted overtime vacation.
- A letter from an authorized Union official granting permission for early return or excess sailing, if applicable.

If prior written permission is not obtained and an Officer returns to work early, they will be subject to a penalty which is loss of vacation benefits for the next six months of employment (180 days).

UPDATE THE SCHOOL & UNION WITH MMC/STCW EXPIRATION DATE(S)

The Calhoun M.E.B.A. Engineering School (CMES) requests that every M.E.B.A. member and applicant submit the expiration date for their Merchant Mariner Credential to them. This info will

allow CMES to better determine how many BST Refresher and/or BST Revalidation courses should be added to the schedule by understanding how many members need to renew their credentials in a given year. If your STCW Endorsement expiration date differs from your MMC expiration please include that information as well. You can send an email with your info to info@mebaschool.org. Make sure you properly identify yourself (last 4 numbers of SSN will help). A webform on the CMES website (www.mebaschool.org) makes it easy for members and applicants to submit this information.
