NMC ANNOUNCES SERVICE UPGRADES

The National Maritime Center (NMC) has announced three upcoming improvements aimed at making the maritime credentialing process faster, clearer, and more convenient. Coming next month, NMC will introduce their new and improved website which will prioritize user experience and offer plain-language guidance and easy navigation centered on NMC's core services: Merchant Mariner Credentials (MMCs), Medical Certificates (MCs), Courses and Examinations. Key features include streamlined navigation with a new menu and search functionality, access to essential information in 1-2 clicks and a clear "How to Apply" pathway as the central theme, guiding mariners step by step through the application process.

Secondly, also in the new year, NMC will debut its Application Submission and Awaiting Information Portal (ASAP). ASAP is designed to provide mariners with a fast, secure, and convenient way to submit applications online. With the new portal, mariners will be able to submit an MMC Application, submit a Medical Certificate application and upload additional documents for an existing application. This is a one-stop portal to submit mariner documents directly to the NMC – no more e-mailing attachments.

And lastly, coming soon, the NMC will be delivering Medical Certificates by e-mail. The e-mailed Medical Certificate will eliminate mailing delays and the need to request duplicate certificates. With this improvement, mariners can receive their medical certificate via e-mail; save it directly to a mobile device; and print it at their convenience.

Together, NMC says these exciting updates will help simplify the process, reduce waiting times, and give mariners more control over their documents. More details will be shared on the NMC website as they get closer to launch. AVIATION BONUSES SKIPPED FOR MOST PASS WORKERS

The Department of Transportation and Federal Aviation Administration recently announced that air traffic controllers and FAA technicians who continued working through the recent government shutdown without missing a day will receive \$10,000 "Patriot" bonus checks. Though 20,000 aviation workers ensured airspace safety during the shutdown, only 776 of them were eligible for the bonuses.

M.E.B.A. affiliate PASS (Professional Aviation Safety Specialists) noted its appreciation that 423 PASS-represented employees in the FAA's Technical Operations Division and others in the Flight Program Operations were slotted to receive the bonus. However, they said that overall, more than 6,000 PASS-represented employees worked without pay during the shutdown.

A PASS statement noted, "They maintained all of the equipment and systems needed by air traffic controllers to communicate with pilots to keep the National Airspace System (NAS) operational and the American flying public safe. Other employees performed a wide range of critical services needed to maintain the aviation ecosystem. It took many hands to ensure that not one delay during the historic 43-day shutdown was attributed to equipment or system failures."

PASS represents over 11,000 Federal Aviation Administration and Defense Department workers throughout the air traffic control system. About 40 percent of them were furloughed during the shutdown while 60% remained on the job, though they weren't receiving checks. Lawmakers ultimately passed a continuing resolution to keep the government funded through January 2026.

Sen. Tammy Duckworth (D-Ill.), the ranking member of the Senate aviation subcommittee, is urging DOT to extend its \$10,000 bonus to all air traffic controllers and FAA technicians who worked without pay during the shutdown. She said, "Excluding 96 percent of the Federal Aviation Administration's (FAA) Air Traffic Controller and Technician workforce from this bonus is unfair, divisive and disrespectful to the over 20,000 dedicated Federal employees who worked under

extremely stressful conditions to ensure our Nation Airspace System (NAS) was safe during the 2025 shutdown."

ITF ADDS TO FOC LIST

The International Transport Workers' Federation has added three more countries to its Flag of Convenience (FOC) shipping list swelling the number of countries which take registration fees but avoid flag state responsibilities. The majority of ship registrations in the newly added states are taken from owners with no link whatsoever to that country. They are exploiting a loophole in international law in order to employ cheap labor and avoid taxes.

Dominica, The Gambia and Niue are the latest flags added to the list after a meeting of the ITF's Fair Practices Committee made up of seafarer and docker unions from around the world. The additions bring the total number of FOC flags to 48 countries.

"We've been monitoring ships sailing under these three flags this year, and after carrying out the necessary due diligence we can confirm their designation as new Flags of Convenience," said Steve Trowsdale, ITF Inspectorate Coordinator. "If you are a flag state and you take registration fees, then you have an obligation to ensure the rights of seafarers on vessels under your flag are respected – let there be no doubt that the ITF is watching and that our global network of inspectors will do everything in their power to protect the seafarers on these vessels."

The ITF defines an FOC ship as one flying the flag of a country other than its actual ownership. ITF released a summary of the three nations' inclusion on the list:

The Gambia: from having zero tankers in 2023 to more than 35 by early this year, the registry is strongly associated with the 'dark fleet'. Research showed that 99% of its tankers were under sanctions or believed to be carrying sanctioned commodities, although Gambia now claims to be vetting the registry.

Niue: the registry opened in 2012, but as of this year ITF data shows that where ownership of its 59 vessels can be confirmed it is spread across Asian states including Singapore (16), Malaysia (2), Japan (2), Indonesia (7), India (1), Hong Kong (1) and Thailand (1), in addition to the Netherlands (1).

Dominica: of the registry's 43 ships, 30 ships have ownership in the UAE (7), India (7), Kazakhstan (3), Saudi Arabia (2), USA (2), Barbados (2) and Norway (2), in addition to Australia (1), Cyprus (1), Finland (1), Great Britain (1) and Guinea-Conakry (1).

POPE ESTABLISHES APOSTLESHIP OF THE SEA AS OFFICIAL CHURCH ENTITY

Pope Leo XIV has formally recognized the Apostleship of the Sea as the Church's central organization responsible for pastoral outreach to the "people of the sea." The decision, announced Thursday in a signed Papal document, also includes approval of the group's statutes. For decades, the Church has supported seafarers, port workers, fishermen, and their families — people who often cannot rely on regular parish life due to constant travel and isolation. The Pope's decree says this new central body stems from "the fervent desire that the Church's spiritual care in the pastoral ministry of the sea may continue with enthusiasm and generosity."

The move follows a global consultation that began in 2022, bringing together national directors and bishops involved in maritime ministry. Discussions continued through 2025 to clarify the mission and structure of the newly established entity. The Dicastery for Promoting Integral Human Development coordinated the process and will oversee the Apostleship of the Sea in line with the Church's current governing norms.

Apply for Vacation and Port Relief Benefits early to avoid the year-end rush. - FILING DEADLINE: The deadline for issuing checks dated in 2025in the Plan Office is Wednesday, December 17, 2025. DIRECT DEPOSIT: The final Direct Deposit Transfer for 2025 will be made on 12/18/2025 and the funds will be deposited into bank accounts on 12/22/2025. Any requests for Port Relief and Vacation checks received after 12/17/25 at 12:00 PM EST will be paid in the order received beginning 1/2/2026.

Any member who requires that his/her check be dated in 2025 must file before this deadline. Remember, Thursday, December 25, 2024 and Thursday, January 1, 2026 are holidays and the Plan Office will be closed. It is always wise to plan ahead, so you should verify the specific holiday schedule with the Plan Office Representative.

Split Your Vacation Payments between 2025 and 2026 - You can submit an Application for Vacation Pay prior to the end of the year and request that the payment of your vacation benefits be split. Two checks will be issued to you, one in 2025 and a second in 2026. The 12/17/2025 deadline applies to split claims also. The vacation benefits paid in this manner MUST be a continuous vacation period.
