## APL CONTRACT EXTENDED TO ACCOMMODATE ONGOING TALKS

M.E.B.A. continues negotiations with American President Lines on a new agreement as the parties agreed to extend the current expiring contract to accommodate ongoing talks. The Union is working on a new agreement covering Deep-Sea engineers as well as Port Engineers. The current agreement expired on September 30<sup>th</sup> but the parties extended its expiration to October 5<sup>th</sup>.

The M.E.B.A. negotiating team led by Executive Vice President Adam Vokac has already met with APL several times and talks are continuing in Oakland this week. L.A. Branch Agent Rich Doherty and Oakland Patrolman Maxim Alper are also involved in negotiations along with an M.E.B.A. rank and file team which includes APL 1<sup>st</sup> A/E Trevor Lapham and C/E Torey Zingales.

### MOLA MEETING IN OAKLAND

M.E.B.A. took part in a Merchant Officers Labor Alliance (MOLA) meeting last week in Oakland discussing a number of topics of mutual interest with MM&P counterparts. The MOLA was formed between the M.E.B.A. and MM&P over a decade ago to strengthen our organizations with an eye toward securing stronger contracts and increased job security.

MOLA's Joint Operating Committee (JOC) discussed a series of initiatives to help advance the interests of both unions. Taking part in last week's meeting for the M.E.B.A. were MOLA JOC principals including President Marshall Ainley, Executive V.P. Adam Vokac and Secretary-Treasurer Bill Van Loo. The MM&P JOC in attendance included its President Don Marcus, Gov't Affairs/Gulf

Ports V.P. Klaus Luhta and Pacific Ports V.P. Lars Turner. MM&P Pacific Coast Agent Jeremy Hope also participated.

It was a productive meeting that touched on topics including common collective bargaining agreements, the Pass-Through agreement, political races and union halls among other issues.

# MARINE HIGHWAY PROGRAM PROMOTED AT SUNY CONFERENCE

At a conference last week staged at SUNY Maritime College, Maritime Administrator Mark Buzby and other guests talked up the continued development of a short sea shipping system in this country. MarAd is resharpening efforts to promote America's Marine Highways to help reduce congestion on major roadways and improve the flow of commerce within the US. while reducing air pollution and creating new jobs. SUNY Marine Transportation professor Capt. Eric Johansson said that such events like last week's conference held in Fort Schuyler, NY are needed to help promote such a system with policymakers and with the public-at-large. "For marine highways to be successful in this country, we need to raise awareness of the advantages short-sea shipping has to offer," he said.

At the conference, MarAd hailed the recently released plan by the NY/NJ Port Authority as well as the New York Economic Development Corporation (NYCEDC) to create the North Atlantic Marine Highway Alliance. The new coalition looks to promote utilization of barge services to offset the use of trucks and supplement rail cargo to and from the Port of New York and New Jersey.

The NYCEDC is investing \$100 million in infrastructure to promote and establish waterborne transportation alternatives in and around the region.

## MSC HOSPITAL SHIP READIED FOR LATIN AMERICA MISSION

The Military Sealift Command hospital ship USNS COMFORT will be leaving Norfolk next week for yet another high-profile mission – this one in South and Central America. M.E.B.A. represents the engineers in MSC's Civilian Mariner fleet.

As part of Operation Enduring Promise, the COMFORT will take part in an 11-week medical assistance mission working closely with host-nation health and government partners in Ecuador, Peru, Colombia, and Honduras. The purpose of the deployment is to help relieve pressure on host nation medical systems partly due to an increase in migrants crossing their borders and provide care to the appropriate communities.

The ship's crew will be supplemented by more than 200 U.S. and partner nation military doctors, nurses, and technicians. In addition, about 60 medical and dental professional volunteers from non-governmental organizations will be on board to support the medical assistance mission. During the mission, USNS COMFORT will visit Esmeraldas, Ecuador; Peru (port to be determined); Riohacha and Turbo in Colombia; and Puerto Castilla, Honduras. Specific dates for each port visit will be announced several days prior to the hospital ship's arrival.

During each visit, COMFORT's medical team expects to treat approximately 750 patients per day at each medical site on shore, and anticipate conducting up to 20 surgeries per day aboard the vessel.

### D.C. PANEL DISCUSSES CHINA'S THREAT TO MARITIME SECURITY

M.E.B.A.'s American Maritime Congress took part in a half-day panel discussion centering on China's Belt and Road Initiative (BRI), a plan to connect more than 70 countries via an overland "belt" and a maritime "road." USA Maritime co-sponsored the Washington D.C. event with General Electric at the Center for Strategic and International Studies, a leading Washington think tank. USA Maritime is a coalition of maritime unions, associations and shipping companies – including the M.E.B.A. and AMC – fighting for the U.S. Merchant Marine.

The panel included Vice Admiral Andy Brown, CEO of the NDTA and former deputy of TRANSCOM and focused on the emerging threat that China's multi-trillion dollar, world-wide infrastructure program poses to maritime security. Specifically, VADM Brown pointed out that the Chinese merchant marine, including its ships, civilian mariners and international port infrastructure regime was the cornerstone of how Beijing has transformed commercial maritime dominance into an expanded military presence throughout the globe. ### WATER, WIND AND WAVES

Removed from present day maritime shipping in terms of time and technology, a special exhibit at the National Gallery of Art in Washington, DC offers a spectacular look into the Golden Age of Dutch shipping. Illustrated through dozens of paintings and drawings and complemented by various large-scale ship models, the *Water, Wind, and Waves* exhibit highlights the Dutch mercantile might of the 17<sup>th</sup> century.

In the 1600s, the Dutch rose to greatness from the riches of the sea. With their massive fleet of cargo ships, they became leaders in international maritime commerce. Their warships commanded the high seas, facilitating oceangoing trade. Dutch fishing vessels and near shore and riverine marine commerce flourished during this golden age. All of these varying maritime activities as well as the beauty and power of the sea are finely illustrated in this exhibit. The exhibit continues at the National Gallery of Art in Washington, DC through November 25, 2018.

The National Maritime Center will make sure mariners whose Merchant Mariner Credentials didn't survive Hurricane Florence can secure duplicate MMCs free of charge. A statement of loss should be provided to NMC by fax at (304) 433-3412 or by e-mail to IASKNMC@uscg.mil. The statement should include: Mariner's full name; Date of birth; Reference number or SSN; Mailing address; Phone/email; Circumstances surrounding MMC loss. Alternatively, mariners can submit a CG-719B, Application for MMC, to one of the Regional Examination Centers with the information above. Questions or concerns can be answered via the NMC website or NMC Customer Service Center by e-mailing IASKNMC@uscg.mil, by using the NMC online chat system, or by calling 1-888-IASKNMC (427-5662).
