### NEW THREE-YEAR AGREEMENT WITH SEACOR FINALIZED

M.E.B.A. has finalized new three-year Collective Bargaining Agreements with Seacor/Waterman retroactive to June 3<sup>rd</sup>. The new agreements cover both licensed engineers for the Pure Car/Truck Carriers (PC/TCs) GREEN COVE, GREEN LAKE, GREEN POINT, GREEN RIDGE, as well engineers onboard the heavylift vessels OCEAN GIANT and OCEAN GLADIATOR.

Among other items, the new agreements bring in strong wage and wage related items increases, OT, duty pay and MPB improvements, medical, training and JEC bumps, as well as a slew of work right upgrades.

The M.E.B.A. negotiating team was led by Gulf Coast Vice President Adam Smith, along with Tampa Branch Agent Nicole Greenway and Headquarters Contracts Officer Mark Gallagher. Input was delivered by Seacor sailing members and rank-and-file participating in negotiations included Doug Berdel, Brian Kane, Seth Kaye, Pat Lowe, Eric White and Alex York.

The agreements are available for review by members and applicants in good standing at the M.E.B.A. Union halls.

# SENATE CG BILL AUTHORIZES SA/SH REFORMS, SHORESIDE INFRASTRUCTURE, OCS CREWING PROVISION EXCLUDED

The newly introduced Senate Coast Guard Authorization bill calls for funding to enhance Coast Guard operations, help the service replace and modernize its cutters, and make big shoreside and cyber infrastructure improvements, among other provisions.

It also includes major reforms to prevent sexual assault and sexual harassment in the maritime industry, but does not include a provision, championed by U.S.-flag shipping interests, that would require that mariners serving on foreign-flagged vessels on the Outer Continental Shelf be either U.S. citizens or citizens of the nation where the vessel is flagged. That provision was part of the Coast Guard bill passed in the House. While the Senate's exclusion of the crewing language from the bill darkens its chances of inclusion in a final Coast Guard package, final details will need to be ironed out in a conference committee before it heads to the President's desk. Current law requires that all vessels, rigs, platforms, or other offshore structures be manned by U.S. citizens or lawful permanent residents, but the law has been exploited and a loophole has allowed foreign companies to utilize low-wage foreign mariners for this work, allowing them to skirt U.S. taxes and labor laws.

Among other things, the Coast Guard Authorization Act of 2022 would authorize \$3 billion to address infrastructure repair and replacement backlogs. It would also require better transparency regarding the outstanding shoreside infrastructure needs by requiring an annual submission to Congress. It would also improve oversight and investigations of sexual assault and harassment in the maritime industry and within the Coast Guard.

It would provide the authority to the Coast Guard to revoke mariner credentials if the mariner has committed certain sex crimes. It defines sexual harassment and establishes a process for mariners to report crimes to the Coast Guard. The bill would also strengthen Coast Guard policy to ensure that victims of sexual assault are provided care as soon as possible when deployed upon a vessel, and would expand penalties for the failure to report a sexual assault and harassment at sea.

#### M.E.B.A. MARCHES FOR FERRY WORKERS AT NYC LABOR PARADE

Last Saturday (9/10), M.E.B.A. took part in New York City's annual march celebrating America's workforce in Midtown, with Labor Secretary Marty Walsh leading the way as Grand Marshal. Sponsored by the AFL-CIO and the New York City Central Labor Council, with the theme "Workers Leading, Workers Rising," the parade also featured AFL-CIO's Secretary-Treasurer Fred Redmond and State Labor Commissioner Roberta Reardon as co-chairs - along with tens of thousands of unionized essential workers who weathered the COVID-19 pandemic to keep the city and country running. M.E.B.A. had a large contingent of members and family march in the parade led by Atlantic Coast V.P. Jason Callahan. Organization of Staff Analyst (OSA) members and their president Bob Croghan marched alongside M.E.B.A. in support of a Staten Island Ferry worker contract.

"One hundred forty years after the first New York City Labor Day parade, we...march by the thousands once again to celebrate not just the union champions who came before us, but the working people across this country who are standing up, taking risks and fighting to organize their workplaces," said Redmond. "This holiday is brought to you by the labor movement, and after the events of the last several years, it [is] an honor to walk alongside the countless workers who have sacrificed so much to move our country forward."

#### TENTATIVE RAIL AGREEMENT COULD AVERT FURTHER NIGHTMARE SUPPLY CHAIN HEADACHES

A tentative agreement, reached early this morning after a final grueling 20-hour bargaining session between an railroads and unions representing engineers and conductors, may avert a threatened strike that would have likely begun tomorrow. The unions had been seeking a fair deal for the last three years. In a process that may take a few weeks, the tentative agreement must be ratified by the memberships before it takes effect.

Brotherhood of Locomotive Engineers and Trainmen (BLET) President Dennis Pierce and SMART Transportation Division (SMART-TD) President Jeremy Ferguson issued a joint statement saying that their unions reached a tentative agreement "with the nation's largest freight rail carriers which includes wage increases, bonuses, and no increases to insurance copays and deductibles. For the first time our unions were able to obtain negotiated contract language exempting time off for certain medical events from carrier attendance policies. Our Unions will now begin the process of submitting the tentative agreement to the rank and file for a ratification vote by the memberships of both unions."

The SMART Transportation Division is comprised of approximately 125,000 active and retired members of the former United Transportation Union, who work in a variety of crafts in the transportation industry. The Brotherhood of Locomotive Engineers and Trainmen represents nearly 57,000 professional locomotive engineers and trainmen throughout the United States. The BLET is the founding member of the Rail Conference, International Brotherhood of Teamsters.

## GPS INTERFERENCE, SPOOFING CONTINUES TO BE A THING

The Maritime Administration has issued a new Maritime Security Communications with Industry (MSCI) (No. 2022-010) to highlight continued instances of worldwide GPS interference involving increasingly sophisticated malicious email spoofing techniques within the Marine Transportation System (MTS).

Such interference can result in lost or inaccurate GPS signals affecting bridge navigation, GPS-based timing, and communications equipment (include satellite communications equipment). Over the last six months, areas from which multiple instances have been reported include the eastern and central Mediterranean Sea, Persian Gulf, and the Red Sea. The U.S. Coast Guard Navigation Center (NAVCEN) web page, <u>https://navcen.uscg.gov/gps-problem-report-status</u> contains a chronological list of recently reported GPS problems.

Maritime GPS disruptions or anomalies should be reported immediately to the NAVCEN at <u>https://www.navcen.uscg.gov/report-a-problem</u> or via phone at (703) 313-5900, 24-hours a day.
