M.E.B.A. Decision 2024

This Special Election edition of the Marine Officer continues to be offered every M.E.B.A. election year to apprise members about the qualifications and platforms of candidates vying for office. Candidates were invited to submit their photo and a message limited to 400 words for publication to assist members in making a more informed decision. The statements you'll find in this issue are unedited, showcasing each candidate's original wording, grammar, and even their occasional spelling mistakes.

This issue is packed with key information about the 2024 M.E.B.A. election, to help guide members in good standing to fully engage in this important democratic process. With the unique nature of our industry, M.E.B.A. voters have three months to cast their votes after ballots are mailed out on September 3rd.

The election journey wraps up on December 2, 2024, when an Impartial Administrator, supported by an elected rank-and-file tallying committee, will collect, count the ballots, and release an official report.

This past July, the M.E.B.A. Credentials Committee confirmed the qualifications of all nominees for M.E.B.A. office. Their report is included in this issue, followed by candidate statements organized alphabetically by office, in the order that they'll appear on the ballot.

The position of Seattle Patrolman will be vacant and will be filled by a DEC appointment early next year. The candidates prevailing in the M.E.B.A. District election will assume their positions on January 1, 2025. The winning candidates for each of the five District Executive Committee positions (President, Secretary-Treasurer, Atlantic Coast V.P., Gulf Coast V.P. and Executive V.P.) along with the Branch Agents in L.A., Norfolk, Seattle and Tampa in the 2024 election, by virtue of their office, will comprise 9 of the 20 Delegates to the National M.E.B.A. Convention. 16 members submitted nominations to fill the 11 additional Delegate positions in the New Year. The one-day National Convention will take place on March 18, 2025.

Dive into this edition and get informed – your vote will help shape the future of our Union!

2024 M.E.B.A., District No. 1-PCD Report of the Credentials Committee



July 16, 2024

- We the Credentials Committee, elected by the membership pursuant to Article 10, Section 2(a) of the District No. 1-PCD, M.E.B.A. (AFL-CIO) By-Laws, have examined the nominations for all District No. 1 officers and jobs which were received at District No. 1 Headquarters, 444 North Capitol Street, N.W., Suite 800, Washington D.C. 20001 or by email during the nomination period.
- **2.** The Credentials Committee examined all mailed and emailed nominations.
- 3. All nominations were submitted to the Credentials Committee in accordance with Article 10, Section 1 (a-e) of the District No. 1-PCD, M.E.B.A. (AFL-CIO) By-Laws.
- 4. The Credentials Committee accepted all timely nominations regardless of the method of delivery. Besides mailed nomination packets, the By-Laws also permits nominations submitted by courier, email or delivery in person.
- 5. All nomination letters listed were received in a timely manner at Headquarters as required by Article 10, Section 1(e) of the District No. 1-PCD, M.E.B.A. (AFL-CIO) By-Laws.
- **6.** The dues of all but one nominee were found to be current through the 2nd and 3rd Quarters of (2024) at the time of nomination, in accordance with Article 9, Section 3 and Article 20, Section 8 of the District No. 1-PCD, M.E.B.A. (AFL-CIO) By-Laws.
- 7. The membership status of all nominees was checked and all were determined to have been a "member of the District for one (1) year immediately preceding the date of the closing of the nominations" as required by Article 10, Section 8(a) of the National M.E.B.A. Constitution.
- 8. All disqualified nominees were notified of the reasons for their disqualification, and their right, if any, to appear before the Committee to appeal the decision or appeal to the membership, as required by Article 10, Section 2(c) of the District No. 1-PCD M.E.B.A. (AFL-CIO) By-Laws.

- 10. The campaign statements submitted by the nominees were reviewed and will be limited to 400 words in accordance with the M.E.B.A. Election Notices issued as All Ports Bulletins on May 20, 2024 and posted on the M.E.B.A. website.
- 11. The two disqualified members failed to meet Article Ten Section 1(c) 5 [Regarding sufficient employment time] or Article Ten Section 8 of the M.E.B.A. Constitution [Regarding eligibility for office in Districts].
- **12.** The Committee wishes to thank the staff at Headquarters for outstanding support and cooperation.

Recommendations from the Committee:

- That candidates include a Plans-generated statement of days of covered employment in addition to discharges, pay stubs and/or vacation stubs. Interpretation of hours worked or other accounting procedures from specific companies makes it difficult to ensure that days of covered employment requirements are met.
- Election material should continue to emphasize that employment in the election year does not count towards required employment.
- **3.** If required information is not included/complete in the submitted nomination packet, the committee is not required to validate.

Dear Brothers and Sisters,

I respectfully ask for your vote for reelection as Atlantic Coast Vice President.

Upon graduating from the US Merchant Marine Academy, Kings Point in

1999, my career began with MSC where I was able to join MEBA. Since 2000, I sailed hard with MEBA, obtaining my **Unlimited Chief Engineer's License** at the age of 27.

This continued until I relinquished my Permanent First Engineer's position with **Matson**, to serve as your Atlantic Coast Vice President.

With outstanding rank and file participation, I have led efforts to obtain great contracts at Maersk, Interlake, Cape May Ferries, Steamship Authority, ACME, Lamont Doherty, and Boston Marine. Importantly, this resulted in getting companies on track to pay the full 11.7 %, higher premium time rates, and compensation for when the vessels are not carrying an electrician.

When Houthi rebels began attacking vessels, I immediately negotiated with Maersk/Liberty to obtain **War Zone Pay**, bonuses, and insurance coverage; many items that had not been paid since the Vietnam War.

Having sailed Chief Engineer for Maersk, I served as a key witness in the Staten Island Ferry 220 case against NYC, where we ultimately prevailed.

MEBA, with rank and file support, obtained a favorable judicial ruling granting pay parity for the Ferry engineers commensurate with Maersk engineers.

Recognizing the critical role of governmental policies in our industry, I am a staunch financial supporter and advocate for the **Political Action Fund** and lobby politicians/lawmakers on Capitol Hill to support vital measures such as the Jones Act, MSP/TSP, and Cargo Preference.

Growing our Union is imperative to our long-term future. Accordingly, I have put a priority on recruitment. 2024 was a record setting high in modern years, as we signed up well over one hundred graduates. Further, I am always working to bring in new work such as **Charleston Industrial and Marine Repair** that I signed up recently.

Looking ahead, in addition to aggressively pursuing Deep Sea and Inland opportunities, we also need to focus on LNG and Offshore Wind jobs that are critical components of our industry's future.

Regardless of whether you are working Deep Sea, Ferries, MARAD, MSC, NOAA, POID, Army Corps, or Shoreside Engineering, every Union member merits the attention and support of leadership.

As your Branch Agent, I will fight for higher base wages and for better Pension/MPB contributions for all officers. No longer can we accept subpar contracts and MOUs; it is time to renegotiate and secure better deals for all mariners under

our wing. My father and grandfather were air traffic controllers with the union NATCA, and they enjoy a substantially better pension than our current pension.

Instead of having a 30% base pay retirement with yearly increases in cost of living after 20 years- as Branch Agent I aim to join the Board of Trustees and fight for a 40% base-pay retirement after 20 years that increases yearly with cost of living. I also aim to include 401k matching up to 5%.

When it comes to contract negotiations, we cannot afford to send untrained and inexperienced negotiators into these discussions. As your Branch Agent, I pledge to advocate for hiring professional negotiators and legal representation at contract negotiations, ensuring that we have the resources necessary to achieve favorable outcomes for our union members. ILWA only has a few thousand more members than M.E.B.A- and yet they are a much stronger union than our own.

Additionally, we must explore relocating our Los Angeles hall to a more strategic location that better serves the needs of our members.

I am deeply troubled by the ongoing issues surrounding APL work uniforms and the exploitative practices of CMA CGM. As your Branch Agent, I vow to take

Nov. 25, 2024 Special Meetings to Elect M.E.B.A. Tallying Committee

In accordance with the M.E.B.A. By-Laws, six M.E.B.A. Union halls will hold Special Meetings on November 25, 2024 to elect a six-person rank-and-file Tallying Committee to oversee the tabulation of election ballots.

Members of the Tallying Committee will be elected at the meetings in New York (New Jersey), Norfolk, Seattle, Houston and Tampa. One alternate will be elected at the meeting in San Francisco (Oakland).

According to the M.E.B.A. By-Laws, no M.E.B.A. official or candidate for office or job is eligible for election to this Tallying Committee.

Election Campaign Mailing Service Instructions

Any request for a list(s) of District No. 1-PCD, M.E.B.A. membership mailing addresses from Headquarters for the purpose of M.E.B.A. election campaign related mailings, must be made in writing.

The request should specify whether a list of the entire M.E.B.A. membership or one or more subset(s) of the membership (i.e., by bargaining unit or geographical location), is needed. Please mail your request to the following address:

Each request for a campaign mailing list **MUST BE ACCOMPANIED** by a check in the amount of \$100.00 per list per mailing. The check should be made payable to District No. 1-PCD, M.E.B.A. to cover the cost of producing the mailing list and sending the list to the campaign mailing service.

The campaign mailing service will be provided by The Kelly Companies (Kelly Press) in Cheverly, MD. *The membership list will be sent from M.E.B.A. Headquarters directly to the campaign mailing service location and the candidate will at no time have direct access to the list.* Any candidate requesting a mailing list is responsible for contacting The Kelly Companies to arrange payment for the direct mail services, including postage.

Dues Must Be Current for Vote to Count

The M.E.B.A. By-Laws state, "No member shall be entitled to any benefits of the Union or be considered in good standing unless his [or her] dues are paid up for the full current calendar quarter or paid in accordance with any dues check-off system under any collective bargaining agreement maintained by the National or this District."

According to our By-Laws, members who are not in good standing by November 15, 2024, with dues paid in accordance with the M.E.B.A. By-Laws, through the end of the quarter where applicable, are not eligible to vote in the upcoming M.E.B.A. election.

In addition, with respect to the payment of quarterly dues, "no member shall be entitled to any benefits of the Union or be considered in good standing unless his dues are also paid for periods of Leave Without Pay (LWOP), if LWOP is permitted under any collective bargaining agreement to which the District is a party or paid within (60) days of the postmark of any invoice sent by the Union to the member by mail with delivery receipt. Further, with respect to vacation dues, no member including members employed by the Union, Union officials and Representatives - shall be entitled to any benefits of the Union or considered in good standing unless his dues are paid for any vacation period regarding which (1) vacation benefit payments are received from the M.E.B.A. Vacation Plan; or, (2) wages or salary are paid, as in the case of members of bargaining units that do not participate in the M.E.B.A. Vacation Plan, but owe vacation dues. In order for a member to be current on payment of vacation dues, 6% of the gross amount of said vacation benefit payment must either be remitted via any dues checkoff system or by direct payment by the member to the Union no later than the first day of the quarter next following the vacation benefit payment, or paid within sixty (60) days of the postmark of any invoice sent by the Union to the member by mail with delivery receipt."

Mailing of the Ballots & Tabulation

On September 3, 2024, the impartial election administrator will mail out ballots to all members at their address on file at M.E.B.A. Headquarters.

The Union urges all members to make sure Headquarters, not just Plans, has your correct address so that you receive your ballot. Address corrections should be in writing and can be sent to Headquarters by regular mail, email (membership@mebaunion.org) or fill out the Change of Address form on the M.E.B.A. website.

Members should know that the HQ database is NOT LINKED to the databases at the M.E.B.A. Plans office in Baltimore OR the Calhoon M.E.B.A. Engineering School.

The balloting period closes on November 30, 2024 – and ballots should be returned to the designated depository by that day. The ballot collection and tabulation will take place on December 2, 2024. According to the M.E.B.A. By-Laws, ballots not received in the depository when the ballots are collected shall be disqualified and not counted.

Ballot Counting - M.E.B.A. By-Laws - Article Ten, Section 4(a)

A Tallying Committee of five members and one alternate who are in attendance shall be elected at a special meeting held in the Ports of New York, Tampa, Houston, Norfolk, Seattle and San Francisco one week prior to the December meeting of the election year [on November 25, 2024]. One member shall be elected at each of the meetings at the New York Branch, Norfolk Branch, Seattle Branch, Houston Branch and Tampa Branch and one alternate shall be elected at the meeting at the San Francisco Branch. No officer or candidate for office or job shall be eligible for election to this Committee.

The elected Tallying Committee of five members and the Impartial Administrator shall, on the morning of the regular December meeting [December 2, 2024], proceed to the depository and obtain all the ballots which shall be retained in the custody of the Tallying Committee and/or the Impartial Administrator until such time as the ballots are checked and counted.

IMPORTANT NOTICE ON ELIGIBILITY TO VOTE

The M.E.B.A. By-Laws state that no member's ballot shall be counted unless he or she is a member in good standing as of 15 days immediately preceding the closing of the balloting period. You must be current with dues by November 15, 2024 for your vote to count.
